This Field Correspondent (FC) Agreement Form

- ReachOUT.org, Inc., (herein referred to a ReachOUT) is seeking non-paid on and behind camera volunteers to video tape various events and personalities in major cities in the U.S.
- FC's are representatives of Jesus Christ first, and of ReachOUT second. They are asked to behave in such a manner as to not harm their witness of Christ nor the reputation of ReachOUT. They are required to *only* represent ReachOUT and not use these opportunities to advance their own career. FC's should not be giving out different business card, offering scripts, or describing their own projects to people they meet through ReachOUT. This is unprofessional. ReachOUT will, however, be gracious in fielding possible future opportunities for you.
- All FC's must sign this form and have it countersigned by an authorized ReachOUT representative BEFORE any taping can take place. ReachOUT reserves the exclusive right to terminate this relationship at any time. Any person found to be falsely representing himself or herself, as a FC of ReachOUT will be prosecuted to the fullest extent of the law.
- All original tapes must be mailed to ReachOUT at PO Box 173, Garnerville, NY 10923. ReachOUT.org reserves the exclusive right to air and edit any footage. ReachOUT will, however, be gracious in our allowing the FC to use footage for other reasons as long as it is done with our approval.
- No music can be included on the tape unless it is incidental background music being played in a public place.
- No web site addresses, phone numbers, email addresses, street addresses or any other contact information may be included on the tape. If it is, it will be edited out.
- No commercial products can be promoted or highlighted in the tapings. ReachOUT reserves the exclusive right to determine what is deemed to be a showing of commercial products.
- No person or animal can be harmed in the making or producing of your tapes. We require FC's to NOT attempt any activity that could be dangerous in nature. For example, filming the breaking up a street fight. Please use your discretion! By signing this form you hold ReachOUT, its employees, and volunteers harmless for any injury or death that may have occurred, whether directly or indirectly, during the production of your tape.
- All FC's agree to the ReachOUT Statement of Faith and Beliefs and agree that they will not speak against them.

ReachOUT.org, Inc., Statement of Faith and Beliefs

The Scriptures are God's "heart" revealed to mankind. The reason God wants us to know His heart and the truth is so we can live it and share it with others. God wants us to be "imitators" of Him, and His chief characteristic is love. We believe the following are crucial teachings of Scripture:

1. That the Scriptures are "God-breathed," perfect in their original writing, without flaw or contradiction, and provide the only sure and steadfast basis for faith and worship.
2. There is one God, eternally existent in three Persons: Father, Son, and Holy Spirit. That He is "the only true God" (John 17:3), holy and separate from all His creation. He is a personal God who has committed Himself to us in writing in the Holy Bible.
3. That Jesus Christ is fully man and fully God. Jesus was manifest in the flesh; and is the perfect expression of God's love (John 1:1). Jesus Christ is the "last Adam," the only-begotten Son of God; born of the Virgin Mary; lived a sinless life; completed numerous divine miracles; suffered, and died as a payment for all men's sins; was buried and was raised (bodily resurrected) from the dead; ascended into heaven, and sits at the right hand of the father; is involved in an ongoing mediation work for mankind, and will personally return in power and glory.
4. The Lord Jesus Christ is the Head over all matters to the Church, His Body, & there is spiritual unity of believers in Christ.
5. That God provides forgiveness of sins, the resurrection of the body, and life eternal. That there is resurrection of both the saved and the lost; those saved unto the resurrection of life, and those lost unto the resurrection of damnation.
6. That salvation is a free gift of God, apart from the works of the law. That for the salvation of lost and sinful men, rebirth of the Holy Spirit is absolutely essential.
7. That the present ministry of the Holy Spirit dwelling in each and every Christian enables us to live a godly life.
